

Terms and Conditions for Winterent

1. Introduction

Welcome to our Winter Clothing Rental Service! This document outlines the terms and conditions governing the rental of winter clothing sets. By using our services, you agree to comply with these terms.

2. Rental Process

2.1. Eligibility

Person responsible for the reservation must be 18 years or older. You are responsible for providing accurate information during the rental process, including personal details, addresses and payment information.

2.2. Collection and Return

Collect your clothing at the time specified in your reservation. You can return your clothing at any time before the end of your rental period.

2.3. Full set price only

Our clothing set always includes a jacket, trousers, winter boots, mittens and tube scarf, and are not rented out separately.

2.4. Delivery & Pick up

Any possible delivery and/or pick up fees always apply to one single trip.

3. Rental Terms

3.1. Rental Period

The rental period starts when you collect the clothing set and ends when you return it. Late return costs an additional charge of 13 € each day per set.

3.2. Condition of Clothing

You are responsible for returning the clothing sets in the same condition as you received them. Any damage to the product results in a repair fee, or the full replacement value of the item. Normal wear and tear is accepted. Minor defects in the product are not a cause for refund. Clothing returned in dirty condition will incur an additional washing fee.

Repair cost: 50 € per item

Washing cost: 15 € per set

Full value of the items:

Jacket 140 €

Trousers 90 €

Shoes 80 €

Mittens 30 €

3.3. Cleaning

Do not wash the clothing. We handle the cleaning and maintenance of all clothing items.

3.4. Lost or Stolen Items

You are responsible for the rented items. If any items are lost or stolen, you will be charged for the full price of their replacement value.

4. Charges and Payments

4.1. Rental charges

Rental charges are clearly stated on our platform. You agree to pay the specified charges for the rental period.

4.3. Payment Methods

We accept payment through the methods indicated on our platform, including credit/debit cards and other payment options.

5. Cancellation and Refunds

5.2. Refunds

If we are unable to deliver your pre-reserved clothing set for any reason, you will be given a full refund. If there is a considerable quality or any other comparable issue with our items, you will be provided with a replacement for the defective item(s).

5.3 Cancellation and changes

After a booking is made with Winterent, it is possible to cancel or change the details or dates of the reservation up to 48h prior to collection time. After this Winterent has the right to charge the full amount of the reservation value.

We are not responsible for any injuries, accidents, or losses that occur during the use of our winter clothing sets.
